

- a. On General Voting Day (November 15, 2008), you must be eighteen (18) years of age or older;
- b. you must be a Canadian citizen;
- c. you must have resided in British Columbia for **at least six months** (since May 15, 2008) immediately preceding November 15, 2008;
- d. you must have resided in School District No. 28 or have been the registered owner of real property in the School District, for **at least 30 days** (since October 15, 2008) immediately preceding the day of voting (November 15, 2008); and
- e. you must not be disqualified by the School Act or any other enactment from voting in the election or be otherwise disqualified by law;

#### Resident Electors:

Resident electors must produce two pieces of identification (at least one with a signature) at the time of voting. The identification must prove both identity and residency. Picture identification is not necessary.

#### **Document identifying electors**

- (1) The classes of documents that may be accepted as evidence for the purposes of section 57 or 57.1 of the *Local Government Act*, or for the purposes of sections 30 or 30.1 of the *Vancouver Charter* are
  - a. a British Columbia Driver's License.

  - an Owner's Certificate of Insurance and Vehicle License issued by the Insurance Corporation of British Columbia.
  - d. a British Columbia CareCard or British Columbia Gold CareCard.
  - a Ministry of Social Development and Economic Security Request for Continued Assistance Form SDES8,
  - f. a Social Insurance Card issued by Human Resources Development Canada,
  - g. a Citizenship Card issued by Citizenship and Immigration Canada,
  - h. a real property tax notice issued under section 369 of the *Local Government Act* or section 21 of the *Taxation (Rural Area) Act*.
  - i. a credit card or debit card issued by a savings institution as defined in section 29 of the *Interpretation Act*, or
  - j. a utility bill issued for the supply of electricity, natural gas, water, telephone services or coaxial cable services by
    - i. a public utility as defined in section 1 of the *Utilities Commission Act*,
    - ii. a gas utility as defined in section 1 of the Gas Utility Act,
    - iii. a water utility as defined in section 1 of the Water Act,
    - iv. the British Columbia Hydro and Power Authority, or
    - v. a corporation licensed by the Canadian Radio-television and Telecommunications Commission for the purposes of that supply.

#### **Non-Resident Property Owners:**

Non-resident property electors must be prepared to produce two pieces of identification at the time of voting (at least one with a signature), proof that they are entitled to register in relation to that property, and if applicable, written consent from all of the individuals *who, together with the individual registering, are a majority of the individual owners of that property.* Further information about the requirements for registering as a non-resident property elector is available through the office of the Secretary-Treasurer during regular business hours.

#### BAKED STUFFED CHICKEN


6-7 lb. chicken







#### BOWRON LAKE LODGE BURNS TO THE GROUND

On a quiet Saturday morning, Oct 4th 2008, while many Bowron locals were away, or out cutting firewood, or searching the bush for their elusive winters meat, the main building of the Bowron Lake Lodge, owned by the McKitrick family burnt to the ground. Around 10am, lodge employee,

Christine, spotted fire licking up the back wall of the historic log building. Within 30 minutes, owner Jim McKitrick along with 6 locals and 4 visitors were involved in trying to contain the fire. A water pump and fire hose arrived on scene and hope arose that we might actually have a chance at saving the front rooms of the building. But a short time later, just as eve-

rything was set up and water charged down the fire hose, sheets of flames started roiling out of the front of the building. Even though we sadly realized that there was probably nothing we could do for the building, we still made an attempt at dousing the flames before admitting defeat and concentrated our efforts towards saving the surrounding structures. By the time more help arrived the old wooden structure was completely engulfed. Although it seemed an eternity as we helplessly watched, in actuality it took only a mere 2 ½ hours the fire to completely consume the for lodge. Luckily no pets or persons were in the building when it caught on fire and no injuries were sustained during the fight.

#### Third Fire on Old Wendle Property

Joseph Wendle first made application to purchase

land at Bear (Bowron) Lake around 1910, shortly after bringing his new bride Elizabeth home to Barkerville. By November of 1918 Joe and Betty had built a 1½-story log home consisting of 8 rooms on a small bluff overlooking the lake. Although they had a home in Barkerville, the Wendles spent a lot of their time at their Bowron Lake home. Unfortunately the house was destroyed by fire during the winter of 1921 while the Wendles

were away in Barkerville. This fire seemed very disheartening to Betty as the house contained many of her original oil paintings and it is rumored that she never painted again because of her loss.

Undeterred, by Aug 1922, Joe began construction on a new 1½ story, 28' x 32' cabin on

the same bluff and by January 1923 the Wendles were again moving into a new lakeside home. In 1927 Joe started a second building, which would serve as a Stopping House for the many tourists that were beginning to visit the area. This Stopping House was later to become the Bowron Lake Lodge. In 1934, the Wendles sold their Bowron Lake land and buildings to the McKitrick family. Over the years the McKitrick family developed the land and buildings into the Bowron Lake Lodge which has catered to visitors for over 50 years.

Sometime in the 1950s the second Wendle house burnt to the ground, leaving an empty knoll overlooking the lake. Joseph Wendle's Stopping House (the Bowron Lake Lodge) graced the shore of Bowron Lake for over 80 years before it too was reduced to charred logs and ash by yet another fire on Saturday morning Oct 4th, 2008.
